AN ACT CONCERNING STATE MILITARY ACCOUNTS.

Be it enacted by the Senate and House of Representatives in General
Assembly convened:

1 Section 1. (NEW) (*Effective July 1, 2012*) There is established an
2 account to be known as the "chargeable transient quarters and billeting
3 account" which shall be a separate, nonlapsing account within the
4 General Fund. The account shall contain any moneys required by law
5 to be deposited in the account, which shall include, but not be limited
6 to, proceeds of room service charges at Camp Niantic. Moneys in the
7 account shall be expended by the Adjutant General for the purposes of
8 billeting members of the armed forces at Camp Niantic.

9 Sec. 2. (NEW) (*Effective July 1, 2012*) There is established an account
10 to be known as the "Army National Guard state morale, welfare and
11 recreation account" which shall be a separate, nonlapsing account
12 within the General Fund. The account shall contain any moneys
13 required by law to be deposited in the account, which shall include,
14 but not be limited to, proceeds of state military morale, welfare and
15 recreation programs. Moneys in the account shall be expended by the
16 Adjutant General for the purposes of operating state military morale,

17 welfare and recreation programs.

18 Sec. 3. (NEW) (*Effective July 1, 2012*) There is established an account
19 to be known as the "Governor's Guards account" which shall be a
20 separate, nonlapsing account within the General Fund. The account
21 shall contain any moneys required by law to be deposited in the
22 account, which shall include, but not be limited to, the proceeds of
23 Governor's Guards programs. Moneys in the account shall be
24 expended by the Adjutant General for the purposes of facilitating the
25 operations of the Governor's Guards.

26 Sec. 4. (NEW) (*Effective July 1, 2012*) There is established an account
27 to be known as the "Governor's Guards horse account" which shall be a
28 separate, nonlapsing account within the General Fund. The account
29 shall contain any moneys required by law to be deposited in the
30 account, which shall include, but not be limited to, donations for the
31 specific purpose of offsetting the costs of maintaining Governor's
32 Guards' horses. Moneys in the account shall be expended by the
33 Adjutant General for the purposes of facilitating the operations of the
34 Governor's Guards.

This act shall take effect as follows and shall amend the following sections:
