AN ACT CONCERNING ADVANCED PRACTICE REGISTERED NURSES' CERTIFICATION OR SIGNATURE.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 17 activities of the advanced practice registered nurse are limited to those
18 activities authorized under section 20-94a of the general statutes.

This act shall take effect as follows and shall amend the following sections:		
Section 1	October 1, 2012	New section

Statement of Purpose:

To allow an advanced practice registered nurse to sign, certify or give an authorization where a physician is allowed or required to do so.
