- 3 In line 21, insert brackets before and after "and" and insert an  
4 opening bracket before "with"
- 5 In line 23, strike the brackets before and after "before" and strike "at  
6 least fifteen days but not more than sixty days prior to"
- 7 In line 24, strike the brackets before and after "or" and strike "and"
- 8 In line 25, insert a closing bracket after "recipient" and after  
9 "recipient", insert "before the recipient's third-party debit or credit card  
10 is charged or before the recipient is required to pay an invoice."

11 In line 33, after "company,", insert "a company whose business  
12 activities are within the scope of 47 CFR 25.201 that uses frequencies  
13 specified in 47 CFR 25.202(a)(7)," and strike the opening bracket before  
14 "or"

15 In line 34, strike the closing bracket after ","

16 In line 36, after "subsidiary", insert ", company whose business  
17 activities are within the scope of 47 CFR 25.201", strike the opening  
18 bracket before "," and strike the closing bracket after "provider"

19 In line 38, after "subsidiary", insert ", company whose business  
20 activities are within the scope of 47 CFR 25.201" and strike the opening

24 subdivision shall not apply to a written contract that contains a  
25 provision for automatic renewal of the contract for a period of time of

27 increase the price the recipient is obligated to pay for the product or  
28 service."
