Title: AN ACT CONCERNING REVISIONS TO THE MOTOR VEHICLE LAWS.

Statement of Purpose: To amend various motor vehicle statutes to expand on-line dealer functions, phase out year of manufacture plates, limit the registration period for experimental test plates, extend the period for people who need second level immigration and citizenship checks, add exceptions to certain towing limitations, repeal licensing requirements for intermediate processors, amend per se statute to include urine samples, add or increase certain fees, and make certain technical corrections.
