Title: AN ACT CONCERNING ANNUAL ADJUSTMENTS TO ASSESSMENT RATES
ADOPTED FOR APARTMENT AND RESIDENTIAL PROPERTIES.

Statement of Purpose: To provide municipalities with a local option to charge interest on delinquent property taxes at a rate of twelve per cent per annum, and to amend the manner in which interest on such delinquent property taxes is calculated so that a payment that is only delinquent for a fraction of a month shall not be charged interest for a full month.
