**Title:** AN ACT CONCERNING THE ADMINISTRATION OF MEDICINE TO STUDENTS WITH DIABETES, THE DUTIES OF SCHOOL MEDICAL ADVISORS, THE AVAILABILITY OF CPR AND AED TRAINING MATERIALS FOR BOARDS OF EDUCATION AND PHYSICAL EXERCISE DURING THE SCHOOL DAY.

**Statement of Purpose:** To require local and regional boards of education to appoint an appropriate number of school nurses for the district that promotes a healthy learning environment; to establish the School Nurse Professional Development Advisory Council; and to amend the duties of school medical advisors.
