Title: AN ACT CONCERNING THE MAXIMUM SURCHARGE FOR ENHANCED 9-1-1 SERVICE.

Statement of Purpose: To determine the appropriate maximum monthly fee that the Public Utilities Regulatory Authority may require providers of local telephone service, commercial mobile radio service, voice over Internet protocol service and prepaid wireless telephone service to assess their subscribers to fund the development and administration of the enhanced emergency 9-1-1 program.
