Title: AN ACT PROHIBITING STATE CONTRACTS WITH ENTITIES MAKING CERTAIN INVESTMENTS IN IRAN.

Statement of Purpose: To ensure that Connecticut is in compliance with the National Defense Authorization Act for Fiscal Year 2012 and the Comprehensive Iran Sanctions, Accountability, and Divestment Act of 2010 by prohibiting state agencies from contracting with entities who have invested twenty million dollars or more in the Iranian energy or financial sectors.
