Title: AN ACT REVISING THE DEFINITION OF A CHILD CARE FACILITY TO CONFORM WITH THE DEFINITION OF A CHILD.

Statement of Purpose: To revise the definition of a child care facility to conform with the definition of a child and permit any person not more than twenty-one years of age who is in school or a job training program to be placed in a child care facility without requiring that person to have been placed in a congregate residential setting prior to his eighteenth birthday.
