Title: AN ACT IMPLEMENTING THE RECOMMENDATIONS OF THE PROGRAM REVIEW AND INVESTIGATIONS COMMITTEE CONCERNING THE REGULATION OF EMBALMERS AND FUNERAL SERVICE ESTABLISHMENTS AND CERTAIN PROFESSIONAL BOARD AND COMMISSION HEARINGS.

Statement of Purpose: To implement the recommendations of the Legislative Program Review and Investigations Committee (1) to require funeral service establishments and embalmers to distribute fact sheets concerning funeral service contracts and to establish a funeral service contract guaranty fund to reimburse consumers for purchased contracts where the establishment did not deposit the funds in an escrow account as required by law, and (2) to require one public and one professional board or commission member to be present at certain professional board hearings.
