**"AN ACT ADOPTING THE UNIFORM ELECTRONIC LEGAL MATERIAL ACT AND THE UNIFORM CERTIFICATE OF TITLE FOR VESSELS ACT."**

1 Change the effective dates of sections 12 to 43, inclusive, to January  
2 1, 2016

3 Strike lines 946 to 970, inclusive, in their entirety and insert the  
4 following in lieu thereof:

5 "Sec. 39. (NEW) (*Effective January 1, 2016*) (a) The department shall  
6 be paid the following fees: (1) For filing an application for a certificate  
7 of title, fifty dollars; (2) for each security interest noted upon a  
8 certificate of title or maintained in the electronic title file pursuant to  
9 subsection (b) of section 25 of this act, twenty dollars; (3) for each  
10 record copy search, forty dollars; (4) for each assignment of a security  
11 interest noted upon a certificate of title or maintained in the electronic  
12 title file, twenty dollars; (5) for an application for a duplicate certificate

13 of title, fifty dollars, provided such fee shall not be required for any  
14 such duplicate certificate of title; (6) for filing a notice of security  
15 interest, twenty dollars; (7) for filing a termination statement relating  
16 to a security interest pursuant to section 26 of this act, twenty dollars;  
17 (8) for filing a secured party's transfer statement pursuant to section 29  
18 of this act, fifty dollars; (9) for filing a transfer-by-law statement  
19 pursuant to section 30 of this act, fifty dollars; (10) for filing an  
20 application for transfer of ownership or termination of a security  
21 interest without a certificate of title pursuant to section 31 of this act,  
22 fifty dollars; (11) for a certificate of search of the records of the  
23 department for each name or hull identification number searched  
24 against, forty dollars; (12) for filing an assignment of security interest,  
25 twenty dollars; (13) for search of a vessel certificate of title record,  
26 requested by a person other than the owner of record of such vessel,  
27 forty dollars; and (14) for a certified copy of any documentation,  
28 information or other record maintained or created by the department,  
29 forty dollars."
