## **OLR BACKGROUNDER: STATUTES WITH CRIMINAL PENALTIES**

This backgrounder lists all statutes with incarceration as a penalty. This updates OLR Report [2006-R-0749](#).

### **CONNECTICUT CRIMES**

Upon our request, the Judicial Branch sent us a list of all crimes and violations contained in their statute file database that have an associated penalty. Using this database, we identified 1,532 crimes with incarceration as a penalty.

Crimes in Connecticut are classified as felonies, which are punishable by imprisonment for more than one year, and misdemeanors, which are punishable by imprisonment for not more than one year. In turn, felonies are classified according to severity as capital or class A, B, C, and class D. Misdemeanors are classified as class A, B, and C. There are unclassified felonies and misdemeanors which are punishable by imprisonment but not designated under one of the above listed classes.

Terms of imprisonment in Connecticut must be for specific periods of time. Table 1 shows the range within which a judge must set the specific sentence. The judge also sets the exact amount of a fine, up to the

established limits. A judge may impose a fine, a term of imprisonment, or both a fine and a term of imprisonment.

**Table 1: Penalties for Connecticut Crimes**

Capital felony	Execution or life imprisonment
Class A felony (murder)	25 to 60 years, up to \$ 20,000, or both
Class A felony	10 to 25 years, up to \$ 20,000, or both
Class B felony	1 to 20 years, up to \$15,000, or both
Class C felony	1 to 10 years, up to \$ 10,000, or both
Class D felony	1 to five years, up to \$ 5,000, or both
Class A misdemeanor	Up to one year, \$2,000, or both
Class B misdemeanor	Up to six months, \$1,000, or both
Class C misdemeanor	Up to three months, \$500, or both

In addition to the penalties contained in Table 1 certain crimes carry a mandatory minimum penalty and certain penalties may be enhanced for persistent offenders.

**TABLES OF CRIMES**

Tables 2 through 7 list Connecticut crimes in categories based on their maximum penalty. For example, the first table includes crimes punishable by more than 20 years in prison and the second table includes crimes with maximum penalties of 10 to 20 years.

For each crime we include the statutory citation, whether it is a felony (F) or misdemeanor (M), its classification or whether it is unclassified (U), a brief description of the crime, and minimum and maximum period of incarceration and fine. We do not indicate whether a minimum prison term is a mandatory minimum sentence that the court cannot suspend (see OLR report 2010-R-0241 for a list of crimes with mandatory minimum sentences). We do not include statutes that enhance penalties based on prior convictions of certain crimes (such as the persistent offender statutes). We also do not include three crimes, related to fire marshal regulations and transporting liquefied petroleum gas, that are repealed as of January 1, 2013 (CGS §§ [29-328](#), [-332](#), [-335](#)).

Some crimes have different penalties depending on the conduct, victim, or number of prior offenses. We list these separately and indicate whether a penalty is for a 1<sup>st</sup> offense (1<sup>st</sup>), 2<sup>nd</sup> offense (2<sup>nd</sup>), 3<sup>rd</sup> offense (3<sup>rd</sup>) or subsequent offense (SBS). We also include a separate entry for a

crime if the law doubles the fine because the crime is committed in a construction or utility zone (C/U).
