Representatives, I do not support house bill 6656. This bill is designed to prevent citizens from owning firearms by making it too expensive to own them. This bill would allow only the wealthy, who have expendable income, to own firearms. This bill is a taking of the second amendment unless citizens are wealthy enough to afford this type of insurance.

Why not propose a law that will require people who cannot defend themselves by gun ownership to pay more in taxes and insurances; these are the people that require more services from police departments. A bill that gives a gun permit holder a tax break should be introduced because these are the first responders, the law abiding, good Samaritans who defend Americans on a daily basis, which, by the way is rarely reported in our liberal News Papers. You, our legislatures, should pass a law that prevents the glorification of any and all murderers. Take away their glory, you have the power to make it law.

This bill will not provide Public Safety and zero criminals are going to purchase this type of insurance.

This bill will only further punish the law abiding, hardworking, tax paying, firearms owning citizens of Connecticut. It will do nothing to penalize the criminal who causes the majority of violent gun related crime in our state. Remember 71% of all gun related crimes are thrown out of court. **OBJECTION TO THE DEFENDANTS APPLICATION FOR ACCELERATED REHABILITATION**

Your Honor, Daniel and Sally Wade come to you as the Victims of the crimes charged to the defendant Boris Churyk on Feb. 20 , 2012. We strongly urge the court to review the facts below.

1) Statutorily, we do not believe that Churyk has met the requirements of the State Statute 54-56e. Churyk's police record has not been reviewed from the previous states that he has lived in. We do not know if Churyk has a previous record of conviction of a crime or a violation, which would preclude him from this program.

2) Statutorily we do not believe that Churyk has met the requirements of the State Statute 54-56e. "Defendants charged with more than one single criminal act or transaction is INELIGIBLE for accelerated rehabilitation". Churyk was charged with two (2) criminal acts : 53a-117 & 53a-64.

3)Sec 54-56e paragraph (b) states that if the court believes the offender will not offend in the future. Below is a history of what Churyk has done to our family. We have video, pictures, mails and eyewitnesses that will confirm all of these facts.

Mr. Churyk has been harassing My Wife and I over the course of six months by the following events, chronologically arranged;

On Sept, 22, :Oct. 01,04,10, 11 etc 2011 Churyk writes slanderous, harassing, vicious, libelous letters to the first selectman making false accusations.

On Oct. 1, 2011 Churyk blared a speaker through the night on and off, which was 50 feet from our bedroom window and over 200 feet from his home to keep us from sleeping.

On Oct. 2, 2011 after being told by police to take it down, Churyk replayed the speaker again past midnight to keep us from sleeping.

On Oct 3, 2011 thru Dec 10 Churyk mounted an illegal hate sign facing our property that read "I (symbol of a heart) U"

On Oct. 7, 2011 Churyk replaced the speaker with large homemade wind chimes. The wind chimes remained after a call to the police department.

On Oct 8, 2011 2:30 am Churyk slams car door repeatedly for 5 minutes straight to keep us from sleeping and to terrorize us.

On Oct 20, 2011 Churyk falsely accuses Mr. Wade of trespassing on his property.

On Nov 11, 2011 11:30 pm Boris drove by our home (in his driveway) blaring his radio waking us from sleeping.

On Nov. 12, 2011 Boris hangs a human head on brush facing our property approximately 30 feet from our bedroom, over 200 feet from his home.

On Dec 02, 2011 2:45 am Sally called elpd for wind chimes no citation for harassment per. Off David Favalora.

On Dec 03, 2011 10:00 am Constable Mark Comeau responds to annoyance of wind chimes, and he states: "Do not call the pd again for wind chimes".

Dec 04, 2011 3:00 am Boris blasts horn for 10 seconds as he passes our bedroom window, to keep us from sleeping.

Dec 07, 2011, on an off through the night wind chimes kept us from sleeping.

Dec 08, 2011, on and off through the night wind chimes kept us from sleeping. Then Boris, at 6:30 am, drove his car, stopped near our bedroom waited a few minutes at 6:30 am and blew his horn.

Dec 15, 2012 Boris *hangs a gruesome decapitated head, which is 31 feet from our bedroom window. A sign that he wants us dead and a way to terrorize us and make us fear for our lives.*

Dec 20, 2012 Sgt Blanchette gets Churyk to remove the macabre.

Feb 12, 2012 10:30 pm Called pd on wind chimes, after 6 months of sleepless nights, new East Lyme woman Police officer has Churyk remove wind chimes.

Feb 20, 2012 11:00 pm Churyk re-hangs Severed human Head, brings out wind chimes, and shoots out window with a BB gun.

Churyk has made false, malicious, libel and slanderous accusations about us to various town departments causing us great financial and emotional stress. Churyk trespassed onto our private posted property and tore down our no trespassing signs on a weekly basis because he does not like the signs facing his property. He has threatened us and put up hate signs. He has photographed us, our family and our friends. He hung a gruesome, bloody, full size, decapitated head near our bedroom window. We have been subjected to various verbal attacks by Mr. Churyk. We no longer feel safe on our property nor within the confines of our home. We are overwhelmed with anxiety knowing that Mr. Churyk has much animosity and hatred towards us and has freely expressed much hate. We are deeply concerned for our safety. We are asking you to impose a Protective order and to remove Mr. Churyk's access to firearms and lessen the threat on our lives.
