Subject: Testimony on Judge Turner

Monday January 14, 2013

Hello Chairs Senator Coleman, Rep. Fox, also to Senator Gerratana, Rep Holder-Winfield and those of you who are friendly colleagues here.

I will say it is a Good Day when Justice is served on those in our government positions

who are not abiding by all the Rules of the Courts, the Canon Laws in our courts(the peoples court), and the Color of Law but I wish all of you the best and pray for your good service.

To the Connecticut Judiciary Committee: I am Cheryl Martone of Westbrook, CT. P.O. Box 165

I hope my testimony here today can make a difference for families in CT. and the Judiciary Committee before me, will know about the corruption, the torture and unlawful ways the courts operate.

I have testified at many hearings here at the LOB, and I'm working to make a better enviroment in our great State of CT. for my child and all the children of Connecticut.

I have one child and he is a victim of abuse by the education system here in Connecticut, the DCF/CPS and many of his civil and educational rights have been violated by almost all the schools he has been in.

John Turner is a Connecticut Superior Court judge, in the Ansonia/Milford district. He hears cases on "PJ-Family Matters" and heard my Family case in Milford, CT. July 2010. of which I was the Plaintiff.

Why and when I presented my case at that time was a matter of such importance and imperative to the upbringing of my child that he neglected to see or listen to the facts of why it had to do with bringing about change for the betterment of my family life and the proper upbringing of my child of which the father was not cooperating with a court ordered "agreement of the parties".

Judge Turner denied me to have equal custody which would have allowed me to protect my child's rights and he not only aided the perpetrator father who was already backed by the law breaking DCF/CPS to offend my rights in the court that day. He was appropriate in his manner but violated the canon laws, A Judge Should Perform the Duties of Judicial Office Impartially and Diligently, he did not exercise this, and did not give me the legal or factual basis for his decision to me, and I am the guardian/parent/mother in protecting my child's rights. I will make a quote from the bible Colossians 3:25 "But he that doeth wrong shall receive for the wrong which he hath done: and there is no respect of persons." Judge Turner also violated me under the rule of law he did not receive all the facts of the case, by his own doings before rendering a decision. He also did not seek to have my witnesses to come forward of which he had would he have known the truth about how badly the DCF/CPS treated/violated me when they had previously kidnapped my beloved child by way of CPS Trial Court in Middletown, CT.

I'm a "Judicial Abuse" Advocate by proxy, by this I represent the Amendments 4 and 5 of the United States 'Bill Of Rights' to protect citizens rights to be free of unwarranted and unwanted government intrusion into one's personal and private affairs, papers, and possessions. Article 12 of the United Nations Universal Declaration of Human Rights states, "No one shall be subjected to arbitrary interference with his privacy, family, home or correspondence, nor to attacks upon his honour and reputation. Everyone has the right to the protection of the law against such interference or attacks." I also give exercise to other biological parents the knowledge and guidance to do so.

All I want is truthful courts. Most are not. I want justice wrought on the ones who are intentionally and deliberately causing injustice in our courts, either by Judges or officers of the courts that cause further harm to our families. Because of what has happened to me in the family and juvenile courts and others, is why I investigate DCF/CPS and the GAL system; (there are several petitions out on the GAL system) for the simple reason they do a hostile take over of your beloved child for their own selfish reasons to traffic children and to profit from the large sums of money to be made by government funding of the taking of these children. The children are sent to strangers houses (not a home) and tortured like you never heard of before. More children die in foster care than in their own loving homes. It was told to me that foster(fakerster) figure will sit at the dinner table with a steak and potatoes dinner on their plate while a child watches them eat, is given scraps of food and is treated like a third class prisoner. I have heard many times from biological parents and the children themselves, that children are drugged and molested by DCF/CPS workers. My child was severerly harassed by them, which is why I say this Judge or any other Judge who violates a parents right to raise their child and protect the beloved child should NOT be allowed to to act as a judge in a court and cause harm to another innocent childs' and innocent parents' lives ever again.

Judge Turner thinks he is making good progress when he never heard all the merits of how my child is being neglected by the father, who is 9 years deadbead, has 2 criminal convictions and is a known alcoholic with no wholesome activities in his life because of the neglectful decision of this Judge Turner as he abruptly rushed my hearing out of the court. I did not spend my valuable time; to send in a grievance complaint about him as it shows here they are all dismissed so why would I.

When the Bar's grievance committee, this committee and other law scholars come forward and give due process to those who are committing crimes against our children and families, it will be worth my time to make report about the inadequate ways our courts are run instead of making public awareness. Let's join together to fix the problems as the courts are not run well. My life and families life have been wrongly, negatively and economically impacted by the wrongs in the courts especially CPS trial (where the whole system do a hostile takeover of our children and do monetary scams on parents), Juvenile court and the system of GAL, Susan cousineau, the BBW. To this day I'm still a victim of abuse and retaliation by the courts and officers of the courts and they are not user or cliente friendly. The only court I have found who is, the Federal court hopefully there will be Justice made there.

I hope that you, the Judiciary Committee can make a positive change for the families of Connecticut and hold the Judges accountable for the negative and neglectful actions in our courts as has been done to me by Judge Turner at Milford, CT.

and not re-appoint him as a Judge.

Judge Moran of Milford, CT court had made a seriously wrongful decision in Nov.2010 when he illegally transferred my Family case out of Milford,CT. when I was heard before him on only a "fee waiver hearing" and had nothing to do with hearing my Family case, he should be fired for being a hostile magistrate as he is not a Judge.

Judge Maureen Keegan also of Milford,CT. court falsely arraigned me on Jan.24, 2012 for a false arrest for trespassing when I was delivering my son his birthday gift on Sept. 19, 2011 and a warrant materialized on Jan. 24, 2012, 4 months later.

I also asked her to recuse herself as being biased and prejudiced, as she heard my testimony at the CT. Supreme Court on May 31, 2011 on the Family court rules and revisions Committee.
