**1. Make Background Checks Universal and Comprehensive.**

**3. Strengthen the Ban on Military-Style Assault Weapons**

Amending the assault weapon sales ban to require that such weapons only have one military style feature (and lists the most prevalent models of assault weapons to ensure they are included)

- A semiautomatic rifle that has an ability to accept a detachable magazine and has at least one of the following: a folding telescoping stock; a pistol grip that protrudes conspicuously beneath the action of the weapon; a thumbhole stock a bayonet mount; a flash suppressor, muzzle brake, muzzle compensator, or threaded barrel designed to accommodate a flash suppressor, muzzle brake, or muzzle compensator, a grenade launcher, second hand grip or protruding grip that can be held by the non-trigger hand, or
- A semiautomatic pistol that has an ability to accept a detachable magazine and has at least one of the following; An ammunition magazine that attaches to the pistol outside of the pistol grip; a threaded barrel capable of accepting a barrel extender, flash suppressor, forward handgrip or silencer; a shroud; a shroud that is attached to,

or partially or completely encircles the barrel that permits the shooter to hold the firearm with the non-trigger hand without being burned; a manufactured weight of fifty ounces or more when the pistol is unloaded; and a semiautomatic version of an automatic firearm; or

- A semiautomatic shotgun that has at least one of the following; A folding or telescoping stock; a pistol grip that protrudes conspicuously beneath the action of the weapon; a thumbhole stock; a fixed magazine capacity in excess of five rounds; an ability to accept a detachable magazine; and second hand grip or protruding grip that can be held by the non-trigger hand.
