**AN ACT CONCERNING AUTHORIZATION OF STATE GRANT
COMMITMENTS FOR SCHOOL BUILDING PROJECTS AND A STUDY
OF ROOF PITCH REQUIREMENTS ON SCHOOL BUILDINGS.**

Be it enacted by the Senate and House of Representatives in General
Assembly convened:

1 Section 1. (*Effective from passage*) The Commissioner of Construction
2 Services, having reviewed applications for state grants for public
3 school building projects in accordance with section 10-283 of the
4 general statutes on the basis of priorities for such projects and
5 standards for school construction established by the State Board of
6 Education, and having prepared a listing of all such eligible projects
7 ranked in order of priority, including a separate schedule of previously
8 authorized projects which have changed substantially in scope or cost,
9 as determined by said commissioner together with the amount of the
10 estimated grant with respect to each eligible project, and having
11 submitted such listing of eligible projects, prior to December 15, 2012,
12 to a committee of the General Assembly established under section
13 10-283a of the general statutes for the purpose of reviewing such
14 listing, is hereby authorized to enter into grant commitments on behalf
15 of the state in accordance with said section 10-283 with respect to the

16 priority listing of such projects and in such estimated amounts as
17 approved by said committee prior to February 1, 2013, as follows:

24 Sec. 2. (*Effective from passage*) The Department of Construction
 25 Services shall conduct a study regarding roof pitch requirements for
 26 school buildings. Such study shall examine the roof pitch requirements
 27 for school building projects as prescribed in subdivision (2) of
 28 subsection (b) of section 10-291 of the general statutes, industry
 29 standards for roof pitch requirements, best practices for school
 30 buildings regarding roof pitch and make any legislative

31 recommendations, if necessary, to the laws regarding roof pitch for
32 school building projects. Not later than October 1, 2013, the
33 department shall submit such study to the joint standing committee of
34 the General Assembly having cognizance of matters relating to
35 education, in accordance with the provisions of section 11-4a of the
36 general statutes.

This act shall take effect as follows and shall amend the following sections:

To authorize state grant commitments for school building projects and to require the Department of Construction Services to conduct a study of roof pitch requirements for school buildings.
