"AN ACT CONCERNING GUN VIOLENCE PREVENTION AND CHILDREN'S SAFETY."

1 Strike subdivision (1) of subsection (a) of section 23 in its entirety
2 and substitute the following in lieu thereof:

3 "(1) "Large capacity magazine" means any firearm magazine, belt,
4 drum, feed strip or similar device that has the capacity of, or can be
5 readily restored or converted to accept, more than seventeen rounds of
6 ammunition, if such magazine, belt, drum, feed strip or similar device
7 is intended for use within a pistol or revolver, or more than ten rounds
8 of ammunition, if such magazine, belt, drum, feed strip or similar
9 device is intended for use within a firearm other than a pistol or
10 revolver, but does not include: (A) A feeding device that has been
11 permanently altered so that it cannot accommodate more than
12 seventeen rounds of ammunition, in the case of a feeding device
13 intended for use within a pistol or revolver, or ten rounds of
14 ammunition, in the case of a feeding device intended for use within a
15 firearm other than a pistol or revolver, (B) a .22 caliber tube

16 ammunition feeding device, (C) a tubular magazine that is contained
17 in a lever-action firearm, or (D) a magazine that is permanently
18 inoperable;"

19 Strike subdivision (2) of subsection (f) of section 24 in its entirety
20 and substitute the following in lieu thereof:

21 "(2) At that person's place of business or other property owned by
22 that person, provided such large capacity magazine contains not more
23 than seventeen bullets, in the case of a large capacity magazine
24 intended for use within a pistol or revolver, or not more than ten
25 bullets, in the case of a large capacity magazine intended for use
26 within a firearm other than a pistol or revolver;"

27 Strike subdivision (6) of subsection (f) of section 24 in its entirety
28 and substitute the following in lieu thereof:

29 "(6) While transporting the large capacity magazine between any of
30 the places set forth in this subsection, or to any licensed gun dealer,
31 provided (A) such large capacity magazine contains not more than
32 seventeen bullets, in the case of a large capacity magazine intended for
33 use within a pistol or revolver, or not more than ten bullets, in the case
34 of a large capacity magazine intended for use within a firearm other
35 than a pistol or revolver, and (B) the large capacity magazine is
36 transported in the manner required for an assault weapon under
37 subdivision (2) of subsection (a) of section 53-202f of the general
38 statutes, as amended by this act; or"

39 Strike subdivision (7) of subsection (f) of section 24 in its entirety
40 and substitute the following in lieu thereof:

41 "(7) Pursuant to a valid permit to carry a pistol or revolver,
42 provided such large capacity magazine (A) is within a pistol or
43 revolver that was lawfully possessed by the person prior to the
44 effective date of this section, (B) does not extend beyond the bottom of
45 the pistol grip, and (C) contains not more than seventeen bullets."
