Title: AN ACT CONCERNING MIXED MARTIAL ARTS.

Statement of Purpose: To permit professional mixed martial arts matches to be held in the state and subject such matches to the same regulation that currently applies to boxing matches, including giving the Commissioner of Emergency Services and Public Protection regulatory authority over such matches, requiring the licensing of the sponsors of and participants in such matches, imposing a tax upon the receipts of such matches and requiring compliance with other safety requirements.
