**Title:** AN ACT CONCERNING THE DEPARTMENT OF ADMINISTRATIVE SERVICES AND THE DISPOSITION OF SURPLUS STATE PROPERTY, SHORT TERM EMERGENCY LEASES, THE DEFINITION OF EXECUTIVE SESSION AND DUPLICATIVE STATEMENTS OF FINANCIAL INTEREST.

**Statement of Purpose:** To streamline the current process for the disposition of surplus real property, to allow the Commissioner of Administrative Services to enter into one-year leases without the approval of certain agencies after the governor declares a building-specific emergency, to allow the state to meet in executive session to discuss real estate transactions and to eliminate the requirement that nonclerical employees in the Department of Administrative Services file duplicate statements of financial interest with the department or the State Properties Review Board and the Office of State Ethics.
