Title: AN ACT CONCERNING PROPERTY AND CASUALTY INSURANCE POLICIES AND PUBLIC ADJUSTER CONTRACTS.

Statement of Purpose: To (1) require personal and commercial risk insurance policies to provide, for a covered loss that requires repair or replacement of damaged items, parts, components or materials, for the repair or replacement of adjacent undamaged items, parts, components or materials to achieve uniformity as to composition, color, texture, size or quality, (2) regulate the declination, cancellation, nonrenewal of and premium increases for homeowners insurance policies, and (3) specify that a home improvement contractor shall not engage in the activities of a public adjuster.
