**Title:** AN ACT CONCERNING PUBLIC SCHOOL POOL SAFETY.

**Statement of Purpose:** To establish standards for who can teach and supervise a physical education course that makes use of a swimming pool; to require an additional supervisor of a physical education class that makes use of a pool if such class has more than twenty-five students; to require school districts to establish a swimming pool safety plan; and to require the Department of Public Health to adopt regulations to include swimming pools and natatoriums located at schools in the Public Health Code.
