**Title:** AN ACT CONCERNING REGIONALISM IN CONNECTICUT.

**Statement of Purpose:** To eliminate regional planning agencies and regional councils of elected officials by January 1, 2015, and to replace such agencies and councils with eight regional councils of governments; to require the Northeastern Region Council of Governments to develop a pilot program to address the human services needs of the region; to require the Capital Region Council of Governments to develop a pilot program to improve services and cost-efficiency in the region; and to require the Valley Council of Governments to develop a pilot program to transfer administration of the HUD Community Development Block Grant Small Cities Program for the towns of Ansonia, Derby, Seymour and Shelton to such council.
