Title: AN ACT CONCERNING THE COURT'S AUTHORITY TO DENY AN APPLICATION FOR THE WAIVER OF COURT FEES.

Statement of Purpose: To provide the court with authority to order (1) a person who receives a waiver of court fees or costs associated with service of process to participate in a program of community service, (2) a party to certain civil actions repay the state for costs incurred due to the granting of fee waivers pursuant to section 52-259b of the general statutes.
