Title: AN ACT CONCERNING PROFESSIONAL BONDSMEN, SURETY BAIL BOND AGENTS AND BAIL ENFORCEMENT AGENTS.

Statement of Purpose: To establish age and education requirements for professional bondsmen and bail enforcement agents and provide for the revocation of their licenses if a restraining or protective order has been issued against them, require any badges worn by bail enforcement agents to be approved, require annual firearms refresher training for holders of a special firearms permit and require approval of instructors offering criminal justice and firearms courses to applicants.
