Title: AN ACT CONCERNING SUBCONTRACTOR PREQUALIFICATION AND CLASSIFICATION THRESHOLDS AND INCREASING THE THRESHOLD FOR REQUIRING COMPETITIVE BIDDING OF PUBLIC WORKS PROJECTS.

Statement of Purpose: To change the threshold for requiring contracts be awarded to the lowest responsible and qualified bidder from five hundred thousand dollars to two million dollars, to require subcontractors to be prequalified at the time of bid submittal and to change the threshold for separate specifications for classes of work from twenty-five thousand dollars to one hundred thousand dollars.
