Title: AN ACT STREAMLINING CERTAIN PROCESSES AT THE DEPARTMENT OF CONSTRUCTION SERVICES CONCERNING CONSTRUCTION MANAGER AT-RISK PROJECT DELIVERY CONTRACTS, THE HIRING OF CONSULTANTS AND CONTRACTS FOR THE INSTALLATION OF PREFABRICATED BUILDINGS.

Statement of Purpose: To allow the construction manager at-risk to prepare the site prior to the completion of the guaranteed maximum price and to allow such price to be determined in phases, to permit the Department of Construction Services to enter into on-call contracts with consultants for programs involving a single client agency and to permit the department to purchase property and services for prefabricated buildings from persons holding a contract with the federal government without using formal bidding procedures.
