**Title:** AN ACT CONCERNING THE GAMING POLICY BOARD.

**Statement of Purpose:** To eliminate the Gaming Policy Board and transfer all licensing and regulatory responsibility that previously existed in the Gaming Policy Board to the Department of Consumer Protection; to simplify the process for issuing permits for charitable gaming by reducing the number of permits available and creating a new permit that allows the permittee to hold, over the course of one year, an unlimited number of single-day bazaars during special events; and to update the cost for each class of charitable gaming permit.
