My name is Andrea Cota Eigner from Cromwell, Ct., mother of Justin Eigner. I testified here on Jan. 9, 2014 at the task force hearing regarding the actions of corrupt court employees. 2 weeks later Jan. 21st, I was retaliated against by Ms. Cousineau and Judge Adelman, giving custody of my beautiful son Justin that day, to my ex-husband, using bogus excuses; she didn't like what I had to say about her, and he said - not enough communication between the parents, not reasons to give sole custody of my son over. The ex. then moved my son out of the state while I have an appeal pending on sole custody, not giving me the whereabouts of my son, all of which would not have happened if the family court were not corrupt. Imagine I don't even know the whereabouts of my precious son, this information is being withheld from me. Others whom testified that day were also retaliated against following the hearing. I have not seen my son in almost 2 years, due to family court corruption. I have been dragged through the Middletown corrupt family court system, (funded by the AFCC, a nationwide group who makes money off children and their families and destroys them), I have been dragged through since September 2008 when my son was legally kidnapped by his father, who no longer wanted to pay child support, and used my son as a pawn for the exchange of his wealthy girlfriends money, with the assistance and abetting of court employees and their business affiliates. To name a few, g.a.l. Susan Cousineau, Judge Gerard Adelman, both AFCC members. Judge Harry Calmar, Dr. Heibel, AMPS, Dr. Black.

On October 6th 2008, g.a.l. Cousineau interrogated and threatened me for 4 hours in a small side room in the court hall regarding my religious beliefs as a Catholic, when she told me I would never see my son again, and if I did not sign physical custody over to my ex. Mr. Eigner, she would put me away somewhere and drug me until I did. Sickened and worried about my son whom I hadn't seen in weeks, I signed him over thinking I would find a way to get him home soon, not knowing how corrupt at the time the family court system is. Another day in the court, two men in suits got off the elevator near the coffee shop, one saying to the other, "If you give Sue Cousineau 12 to 15 k she'll do whatever you want."

The g.a.l.'s, lawyers, judges and other players in family courts need to be prosecuted and punished for the crimes they have committed.

The g.a.l.s' need to be permanently removed, preferably Family Court system abolished, the corrupt AFCC shut down. Passing these bills 5209 and 5138 through legislation will be a long overdue first step in the right direction. Bill 494 is a worst case scenario, do not vote for this bogus bill which will make matters worse for families. Vote yes to bills 5209 and 5138 in hopes it will bring our victim children home to us and straighten out the future for children being brought into this world.

More examples of the corruption;

Myself and others have done auditing on bills forced upon parents. After talking to many parent victims regarding their experiences with g.a.l.'s, attorneys and judges, they revealed they are traumatized by their actions in the taking of their children and over billing on exaggerated services. I have a sample of my long bills here, with over billing on services created to keep the racketeering business going. They purposely make the parents at odds disagreeing with each other to keep them coming back to the courts, while keeping plaintiffs satisfied in order to bring in more wealthy referrals so they can collect more money.

Ms. Cousineau has not met with my son Justin more then once in 5 years, he did not even know who she was when I asked him several times about her. She did not return any of my calls in the past, but two of them. She does not care about the well being of my son, and is only concerned with filling her pockets with cash like most g.a.l.'s, attorneys and judges in the system.

In a hearing on Aug. 12, 2013, Ms. Cousineau states she is Former GAL, and then lies in court on the record Dec. 23rd 2013 stating she never said that she was no longer on the case. She even told me so herself in the court hall, she was no longer on the case. She plays the role whenever she feels it suits her, but yet never does her proper job as a GAL. She finally recused herself Jan. 21st after she retaliated that day in court.

She illegally arranged for Judge Adelman to try and overturn a Federal Judges decision of my debts to her that were dismissed in bankruptcy court, which the Federal bankruptcy court had full knowledge of her assistance, abetting in the legal kidnapping of my son Justin, that did not justify her corrupt bills to me of \$6k (attached).

She threatened my home equity and had already collected \$10k or more from my ex. Another day, after confronting one of the Judges in my case in a closed courtroom, saying to him, I know what is going on in here, you people lie cheat and steal to make money off my child. The judge replied, if you know whats going on and what we are doing, then why come in here wasting everyone's time... All of this of course was stricken from transcripts. Another day in court Ms. Cousineau threw at me, my letters of good character friends family and professionals wrote and signed on my behalf, some of whom testified too... she stated, you could have signed them all. Imagine the rat accusing me of signing a stack of goodwill letters from my loved ones. Behind bars is where criminals like her belong, for the money, lives and relationships they took away from so many children and parents.
