AN ACT CONCERNING MENTAL HEALTH SERVICES FOR MEMBERS OF THE NATIONAL GUARD.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. Subsection (c) of section 27-102l of the 2014 supplement to
2 the general statutes is repealed and the following is substituted in lieu
3 thereof (*Effective July 1, 2014*):

4 (c) In addition to the powers and duties prescribed under section 4-
5 8, the commissioner shall have the following powers and duties:

6 (1) To prepare studies and collect information concerning facilities
7 and services available to members of the armed forces, veterans, their
8 spouses or eligible dependents, including facilities and services for
9 veterans who may have been exposed to a Vietnam herbicide during
10 their periods of military service;

11 (2) To conduct interviews in the nursing homes or hospitals
12 throughout the state to determine the number of veterans admitted
13 and ascertaining which benefits such veterans are currently receiving

14 and are entitled to receive;

15 (3) To cooperate with service agencies and organizations
16 throughout the state in disseminating and furnishing counsel and
17 assistance of benefit to residents of this state who are or have been
18 members of the armed forces, their spouses or eligible dependents,
19 which will indicate the availability of: (A) Educational training and
20 retraining facilities; (B) health, medical, rehabilitation and housing
21 services and facilities; (C) employment and reemployment services; (D)
22 provisions of federal, state and local laws affording financial rights,
23 privileges and benefits; and (E) other matters of similar nature;

24 (4) To assist veterans, their spouses and eligible dependents and
25 family members in the preparation, presentation, proof and
26 establishment of such claims, privileges, rights and other benefits
27 accruing to them under federal, state and local laws;

28 (5) To cooperate with all national, state and local governmental and
29 private agencies securing or offering services or any benefits to
30 veterans, their spouses or dependents;

31 (6) To develop and prepare a long-range plan and mission statement
32 for the Veterans' Home and the veterans' advocacy and assistance unit;
33 [and]

34 (7) To review all appeals made by veterans, their spouses or eligible
35 dependents or family members and render the final decision thereon
36 regarding the denial of admission to any program or the refusal to
37 render any service or benefit which is administered by the Department
38 of Veterans' Affairs, the discharge or transfer from any such program
39 or any disciplinary action taken while participating in any such
40 program; and

41 (8) To develop, within available resources and in consultation with
42 the Department of Mental Health and Addiction Services, the
43 Department of Children and Families, the Military Department,

44 veterans' organizations and local veterans' advisory committees, an
45 outreach program designed to inform members of the Connecticut
46 National Guard, persons honorably discharged from, or released
47 under honorable conditions from active service in, the Connecticut
48 National Guard and such members' or persons' dependents and family
49 members of existing federal and state mental health services available
50 to such individuals, including, but not limited to, transitional
51 behavioral health services available pursuant to section 17a-453d.

This act shall take effect as follows and shall amend the following sections:
