Title: AN ACT CONCERNING REGISTRARS OF VOTERS, THE AUTHORITY OF THE SECRETARY OF THE STATE AND THE STATE ELECTIONS ENFORCEMENT COMMISSION, AND THE POSTING OF REQUIREMENTS FOR VOTER IDENTIFICATION.

Statement of Purpose: To require towns to provide Internet service to the offices of the registrars of voters, to clarify that any declaratory ruling, instruction or opinion issued by the Secretary of the State binding upon registrars of voters and town clerks and enforceable by the State Elections Enforcement Commission and to provide requirements for the form of any such written instruction or opinion, and to require the posting of the state's law concerning identification for voting requirements at each polling place.
