Title: AN ACT AMENDING THE CHARTER OF THE METROPOLITAN DISTRICT IN HARTFORD COUNTY.

Statement of Purpose: To require The Metropolitan District Commission to (1) charge all customers at uniform rates, including surcharges; (2) give nonmember municipalities representation on the district board; (3) post the district budget and minutes of the district board, subcommittees, bureaus, boards and commissions on the Internet web site of the district; and (4) maintain recreational property connected to the Riverfront Recapture project.
