Title: AN ACT CONCERNING THE ENFORCEMENT OF PAYMENTS OF ASSESSMENTS AND USER FEES TO THE CONNECTICUT HEALTH INSURANCE EXCHANGE.

Statement of Purpose: To (1) allow the Connecticut Health Insurance Exchange to make data in the all-payer claims database available to certain public or private entities, (2) specify that health carriers shall comply with applicable provisions of sections 38a-1083 and 38a-1091 and procedures adopted by the exchange board, (3) authorize the Insurance Commissioner to suspend, revoke or refuse to renew the license of a health carrier that fails to pay an assessment or user fee to the exchange, and (4) establish certain standards for stop loss insurance policies in this state for health care or medical benefits.
