Title: AN ACT CONCERNING LIFE INSURANCE PRODUCER LICENSES AND REGISTRATIONS OF BROKER-DEALERS, AGENTS, INVESTMENT ADVISERS AND INVESTMENT ADVISER AGENTS, AND THE INSURANCE COMMISSIONER'S AUTHORITY TO DENY AN APPLICATION FOR AN INSURANCE PRODUCER LICENSE.

Statement of Purpose: To require the Banking Commissioner to provide a monthly list to the Insurance Commissioner of individuals registered with the Banking Commissioner pursuant to section 36b-6 of the general statutes and those individuals who have had such registration denied, suspended or revoked during the preceding ten years, and to require the Insurance Commissioner to take such denial, suspension or revocation into consideration with respect to application for and continuation of life insurance producer licenses.
