House Bill No. 6032

*House of Representatives, March 17, 2015*

The Committee on Environment reported through REP. ALBIS of the 99th Dist., Chairperson of the Committee on the part of the House, that the bill ought to pass.

**AN ACT CLARIFYING PROVISIONS OF THE GENERAL STATUTES CONCERNING THE USE OF BARRIER SYSTEMS FOR CERTAIN PLANTINGS.**

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. Subsection (c) of section 22a-381e of the general statutes is  
2 repealed and the following is substituted in lieu thereof (*Effective from*  
3 *passage*):

4 (c) No person shall plant running bamboo or allow running bamboo  
5 to be planted on his or her property at a location that is forty feet or  
6 less from any abutting property or public right-of-way. Any person  
7 who violates the provisions of this subsection shall be fined one  
8 hundred dollars. In the case of a continuing violation, each day of  
9 continuance shall be deemed a separate and distinct offense until such  
10 time as such bamboo is removed, [or contained by a properly installed  
11 and constructed barrier system.]

This act shall take effect as follows and shall amend the following sections:

The bill, which changes how and where certain types of bamboo may be planted and makes conforming changes to PA 14-100, does not result in a fiscal impact.

This bill makes a conforming change to PA 14-100, which (1) prohibits people from planting, or letting anyone plant, “running bamboo” (i.e., bamboo in the genus *Phyllostachys*, including yellow-groove bamboo) on their property within 40 feet of abutting property or a public right of way and (2) eliminates the option of containing bamboo by a barrier system or above-ground planter. The bill removes an obsolete reference to bamboo that is properly contained.
