"AN ACT CONCERNING VETERANS."

1 Strike everything after the enacting clause and substitute the
2 following in lieu thereof:

3 "Section 1. Subsection (a) of section 14-50a of the general statutes is
4 repealed and the following is substituted in lieu thereof (*Effective*
5 *October 1, 2015*):

6 (a) Except as otherwise provided in this section, the fee charged by
7 the Commissioner of Motor Vehicles for the following items or services
8 shall be twenty dollars:

9 (1) Duplicate of a registration certificate.

10 (2) For each duplicate of a motor vehicle operator's license or
11 identity card, thirty dollars, except that on and after the effective date

12 of this section such fee shall be waived in the case of a veteran
13 submitting a first-time request to have his or her status as a veteran
14 contained on his or her motor vehicle operator's license or identity
15 card and whose veteran status was verified by the Department of
16 Veterans' Affairs pursuant to section 14-36h. As used in this section,
17 "duplicate" shall include any license or identity card that is reissued
18 prior to the expiration date of a previously issued license or identity
19 card, and (A) is identical to the holder's most recently issued license or
20 identity card, or (B) contains modifications to one or more items of
21 information that appear on the holder's most recently issued license or
22 identity card. Notwithstanding the provisions of this subdivision, one
23 duplicate shall be issued, for a fee of five dollars, to the holder of a
24 license or identity card who reaches the age of twenty-one years.

25 (3) Replacement number plate or set of number plates, except as
26 provided in subsection (c) of section 14-253a.

27 (4) Replacement number plate or set of number plates bearing same
28 number as set of replaced plates.

29 (5) Certified abstract of driving history record, or driving history
30 record for applicants for commercial driver's license with passenger
31 endorsement or transportation permit.

32 (6) Name of registered owner.

33 (7) Operator license information.

34 (8) Certification of any copy or record.

35 (9) Certified transcripts of hearing held by the commissioner, three
36 dollars and fifty cents per page with a minimum charge of twenty
37 dollars.

38 (10) Each copy of a motor vehicle operator's completed application
39 for a license.

40 (11) Each copy of a completed application for registration of a motor
41 vehicle.

42 (12) Each copy of a title document provided to a municipality.

43 (13) Each request for information as provided in section 14-10, the
44 amount provided in said section.

45 (14) Each document from a motor vehicle record, as defined in
46 section 14-10, that is electronically maintained by the Department of
47 Motor Vehicles.

48 (15) For any copy or material released from information maintained
49 by the Department of Motor Vehicles for which no fee is established by
50 statute, an amount determined by the commissioner."

This act shall take effect as follows and shall amend the following sections:
