Title: AN ACT REQUIRING CERTAIN HIGHER EDUCATION FACILITIES THAT CONDUCT RESEARCH USING CATS OR DOGS TO OFFER SUCH CATS OR DOGS TO ANIMAL RESCUE ORGANIZATIONS PRIOR TO EUTHANIZING ANY SUCH CAT OR DOG.

Statement of Purpose: To require state and private colleges and universities that use cats or dogs in laboratory research or testing to offer such cats or dogs for adoption by animal rescue organizations after such testing and to establish standards for the provision of proper shelter to dogs.
