Title: AN ACT CONCERNING MUNICIPAL NOTICE PROVISIONS, BLIGHT LIENS AND VOTING REQUIREMENTS FOR ESTABLISHING A DISTRICT TO MAINTAIN WATER QUALITY.

Statement of Purpose: To (1) require municipalities to give notice to mortgage lenders of property violations; (2) allow municipalities to secure liens on any property in the state owned by a person also owning property on which a lien has been placed for violation of a blight ordinance; (3) to include property manager in the entities that may be listed on the registration form filed with a municipality for residential properties in foreclosure; and (4) to modify voting requirements for the establishment of a district to maintain water quality in a lake.
