**Title:** AN ACT CONCERNING THE PAYMENT OF UMPIRES UNDER THE STANDARD FIRE POLICY.

**Statement of Purpose:** To require all provisions, stipulations, agreements and conditions with the form of policy set forth in section 38a-307 of the general statutes to be incorporated without change and prohibit umpires selected pursuant to the appraisal provision of a policy or contract from requiring or entering into agreements or contracts that direct payment for such umpire's expenses be made directly from any award.
