Title: AN ACT CONCERNING THE CONNECTICUT UNFAIR INSURANCE PRACTICES ACT.

Statement of Purpose: To make it an unfair insurance practice to (1) state or imply that if an insured declines a settlement, the insured must institute litigation to recover amounts due under an insurance policy, and (2) fail to refund an overpayment of premium to an individual health insurance policyholder not later than thirty days after such policy is cancelled or such company, center, corporation, society or other entity receives a refund request from the policyholder.
