Title: AN ACT CONCERNING INVASIONS OF PRIVACY.

Statement of Purpose: To (1) provide a criminal penalty for the practice of "upskirting", (2) strengthen penalties for "Peeping Tom" violations, (3) provide for the prosecution of incidents of voyeurism that go undetected for a prolonged period of time, (4) protect victims of voyeurism from public embarrassment, and (5) establish a criminal offense of unlawful dissemination of an intimate image with respect to persons who knowingly disseminate an intimate image of another person with the intent to harass, annoy, alarm or terrorize such other person.
