**Title:** AN ACT CONCERNING RETENTION OF THE COPARTICIPANT OPTION UNDER THE TEACHERS' RETIREMENT SYSTEM AFTER DIVORCE, ELIMINATING THE CAP ON PROFESSIONAL FEES PAID OUT OF THE RETIRED TEACHERS' HEALTH INSURANCE PREMIUM ACCOUNT, CEASING THE CREDITING OF INTEREST ON UNCLAIMED CONTRIBUTIONS FOR INACTIVE MEMBERS OF THE TEACHERS' RETIREMENT SYSTEM AND ELIMINATING CERTAIN OBSOLETE LANGUAGE.

**Statement of Purpose:** To permit a member of the teacher's retirement system to retain the coparticipant designated and the coparticipant option elected at the time of retirement after a subsequent divorce, eliminate the annual cap on professional fees paid out of the retired teachers' health insurance premium account, cease crediting interest on unclaimed contributions for inactive members of the teachers' retirement system and eliminate obsolete language concerning the pension reserve account.
