**Title:** AN ACT CONCERNING THE FAILURE TO FILE FOR CERTAIN TAX EXEMPTIONS, THE EXTENSION OF CERTAIN TAX CREDITS AND DEVELOPMENT PROGRAMS, EXEMPTIONS FROM CERTAIN FINANCIAL ASSISTANCE AND ADMISSIONS TAX REQUIREMENTS, AND VALIDATIONS.

**Statement of Purpose:** To allow certain persons to file for property tax exemptions, notwithstanding certain statutory deadlines, and extend application periods for certain tax credits and financial assistance programs for property development and improvements.
