**Title:** AN ACT CONCERNING HEALTH INSURANCE COVERAGE OF ORALLY AND INTRAVENOUSLY ADMINISTERED MEDICATIONS.

**Statement of Purpose:** To require health insurance policies that provide coverage for intravenously administered medications for the treatment or palliation or therapeutic intervention for the prevention of disabling or life-threatening chronic diseases to provide coverage for orally administered medications for such treatment, palliation or intervention on a basis no less favorable than intravenously administered medications.
