Title: AN ACT CONCERNING EMPLOYEE ONLINE PRIVACY.

Statement of Purpose: To protect employee privacy by barring employers or potential employers from (1) requesting or requiring employees or potential employees to provide passwords or usernames to their personal online accounts as a condition of employment, and (2) requesting or requiring employees or potential employees to invite the employer or potential employer to join their personal online account network.
