Title: AN ACT CONCERNING ELECTRIC FIXED BILL FEES AND GRID MODERNIZATION.

Statement of Purpose: To modernize the electric grid, create a methodology to value distributed energy resources, initiate a distributed energy resource grid integration pilot program, compel the public disclosure of the circuit map of the electric distribution system, alleviate areas of electric distribution system congestion, promote and incentivize the conservation of electricity and provide associated savings to ratepayers by reducing and capping the electric distribution companies' residential fixed charge.
