Statement of Purpose: To establish the Children's Behavioral Health Plan Implementation Advisory Board that shall (1) execute and oversee the comprehensive implementation plan developed pursuant to section 17a-22bb, and (2) ensure the continued collaboration of agencies and stakeholders in order to prevent or reduce the long-term negative impact of mental, emotional and behavioral health issues on children.
