Statement of Purpose: To require each municipality that sponsors a group health policy or plan to submit information regarding such policy or plan to the State Comptroller for analysis and to allow the Comptroller to enter into cooperative health care agreements that may allow individuals to acquire low-cost, high-quality health care.
