Title: AN ACT CONCERNING REVISIONS TO THE CONNECTICUT BUSINESS CORPORATION ACT, THE UNIFORM LIMITED PARTNERSHIP ACT AND THE CONNECTICUT LIMITED LIABILITY COMPANY ACT.

Statement of Purpose: To amend certain provisions of: (1) The Connecticut Business Corporation Act on matters relating to proxies, unlawful distributions, indemnification, voting trusts and qualifications for directors; and (2) the Uniform Limited Partnership Act and the Connecticut Limited Liability Company Act relating to reinstatement following dissolution by cancellation or forfeiture.
