Title: AN ACT CONCERNING REVISIONS TO THE HEALTH INSURANCE STATUTES.

Statement of Purpose: To (1) update the health insurance statutes to reflect changes in federal law, (2) give the Insurance Department the authority to approve small employer group health insurance rates, and (3) specify that health insurance policies may not reduce payments on the basis that an individual is eligible for Medicare unless such individual enrolls in Medicare.
