**Title:** AN ACT CONCERNING THE SECURITY OF CONSUMER DATA.

**Statement of Purpose:** To require health insurers and other entities to implement security technology that encrypts the personal information of insureds and enrollees that is compiled or maintained by such insurer or entity, and to authorize the Insurance Commissioner to adopt regulations in consultation with the Commissioner of Consumer Protection to establish minimum standards for such security technology.
